\$100.00 will be charged for each late pick up and delivery.

TONU fee will not exceed \$150.00.

Detention is paid at the rate of \$40.00 per hour after 4 hours, only if Freight Cowboy is notified before detention starts.

NO Detention will be paid on late arrivals to either shipper or receiver.

Driver is responsible for any down product.

To insure reimbursement - All lumper fees need prior approval.

Layover policy – up to max \$150 layover fee

If a load is Partialed without our consent the carrier will be penalized based on our judgement.

\$100.00 deduction in rate, if carrier agrees to electronic tracking of the load and then does not comply to tracking until delivery or in the event the carrier fails to provide two manual status updates daily. If manually providing updates, the 1st update daily needs to occur before 9:00am Central and the 2nd update between 3:00pm-5:00pm Central. Tracking updates may also be provided electronically though an automated system used by the carrier that tracks the position of the truck, by either by providing them to us live or at a minimum of twice daily, based on the above schedule.
